CALL TO ORDER: 12:34 PM by E. Easley

CORRECTION/APPROVAL OF MINUTES: The minutes of the December 2025 faculty organization meeting were approved.

Dean of the Campus – Dr. Courtney Catledge, report submitted (Appendix 1).

- Enrollment reported at 2,276 (slightly below last year's record).
- Multiple faculty searches underway; three nearing completion.
- Urgent need to hire recruiter during peak recruitment season.
- Strong academic performance among student-athletes (men's soccer, women's soccer, volleyball, baseball).
- Baseball season underway; Valentine's weekend home opener.
- Discussion of potential basketball program; barriers include facilities, housing, and funding.
- Guidance Counselor Lunch and Carolina Day participation upcoming.
- Horizon Grant opportunity available.
- Promoted Give for Garnet (priorities: Soccer, Travel Study, Archaeology Lab).
- Commencement scheduled for May 2.
- No local measles cases; outbreak noted in Upstate SC.

 - N. Lawrence – Housing is also an issue for our existing population of student athletes.

Recent and Upcoming Events

Our new event and instructional space, tentatively called “the Gallery,” now features AirMedia technology, thanks to IT Director Blake Faulkenberry. This technology allows us to hold more dynamic and interactive workshops and presentations, with contributors screen casting from around the room. This tech was also installed the Studio, so expect to see it in use soon.

We are also working with campus art faculty to develop a collection of art from local and student creators to decorate the Gallery. Selection of artwork and early planning began in the fall, and we look forward to completing the project this spring. If you want to take advantage of this cool new space, please reach out with your group or unit’s event.

We are in early planning stages for Health Sciences reviews for BIOL 243/244. These sessions, run by the exceptional Kennedy Bumbrey, will take place in coordination with faculty in advance of exams. If other faculty would like to coordinate review sessions in our areas of coverage—or would like to hold their review sessions in our cool space—let’s do it.

Summary of Tutoring Data

Year-to-year trends: In January, we held the same number of sessions as the previous January. Given that reduced staff and weather-related service disruptions reduced our tutoring availability, this is good news. The appointments were distributed among a marginally lower number of students, though we served more students than in January 2024.

Session distribution trends: We’re seeing typical distribution among the academic divisions, with STEM (including Math Lab) making up more than half of our student contacts. We saw a higher proportion of students holding virtual appointments, which makes sense given the weather challenges and our increased number of virtual hours. We saw very few dual enrollment or student-athlete clients, unfortunately.

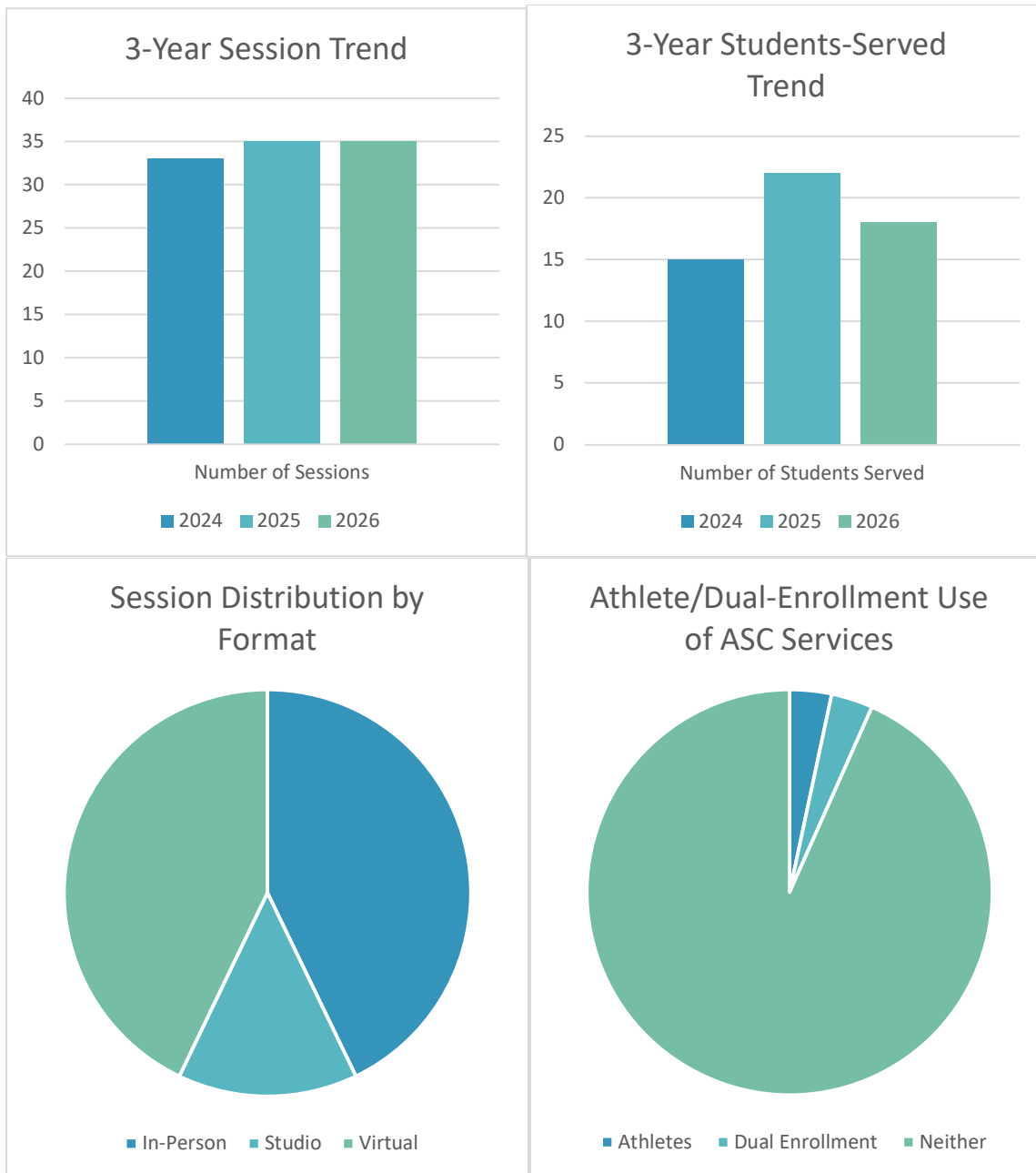

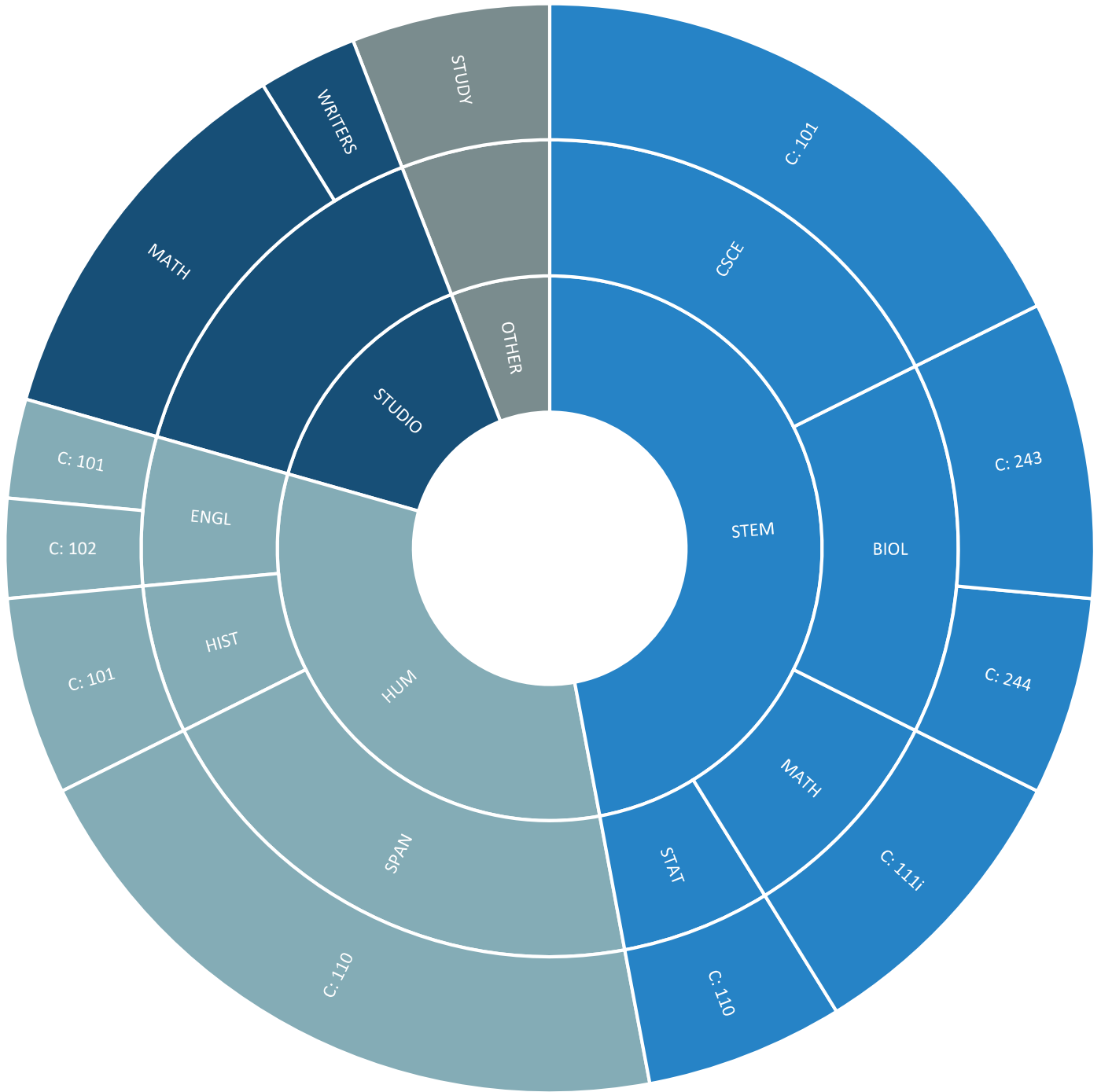

If you elected to receive your W-2 electronically please take the following steps to review, print, or save your 2025 W-2.

- 1) Log into the HR/Payroll System hcm.ps.sc.edu
- 2) On the Employee Self Service screen choose the Payroll tile
- 3) Select the W-2/W-2c Forms Tile
- 4) Ensure that the Tax Year is 2025
- 5) Select View Form
- 6) If you need instructions on filing your W-2 select the square under the heading filing instructions.

Those who did not choose to receive the 2025 W-2 electronically will receive their copy via mail. It will be mailed to the address that is stored in the HR/Payroll system.

Questions about W-2s should be directed to the USC Payroll Department via email payroll@mailbox.sc.edu. When communicating with the USC Payroll Department share your legal name and USC ID so that you may be easily identified and assisted efficiently.

2) 2026 State ORP Open Enrollment

Current participants of the State Optional Retirement Program (State ORP), administered by the SC Public Employee Benefit Authority (PEBA), may participate in the open enrollment period until March 1, 2025.

During the annual open enrollment, State ORP participants may change their State ORP service provider or, if eligible, make a one-time, irrevocable election to join the South Carolina Retirement System (SCRS).

Changes should be made through the [Member Access Account](#). Changes made during the open enrollment period become effective April 1, 2026.

3) MoneyPlus Dependent Care Spending Account and Medical Spending Account

Remember March 31, 2025, is the deadline to request reimbursement from 2024 funds in your Dependent Care and Medical Spending Accounts.

Any funds left in a Dependent Care Spending Account will be forfeited after the reimbursement deadline.

Money left in a Medical Spending Account on December 31, 2024, is eligible to be carried over. Up to \$640 of those funds carried over into the 2025 plan year.

4) Applying for Extended Leave of Absence (Family and Medical Leave – FMLA)

An employee should request an Extended Leave of Absence for absences that are greater than 3 days. Leave may be requested for an employee's own health condition or to provide care to an immediate family member.

Employees may submit these requests directly to the USC Benefits Department through the HR/Payroll System or the appropriate forms may be shared directly with me via email, fax, mail, or hand delivery and I will submit them for review on behalf of the employee.

Employees should request to receive the appropriate forms as soon as they become aware of the need to be away from work for more than 3 days. Division Chairs and supervisors may also request that forms be sent to an employee.

Notifying me via email or telephone will allow me to start the process.

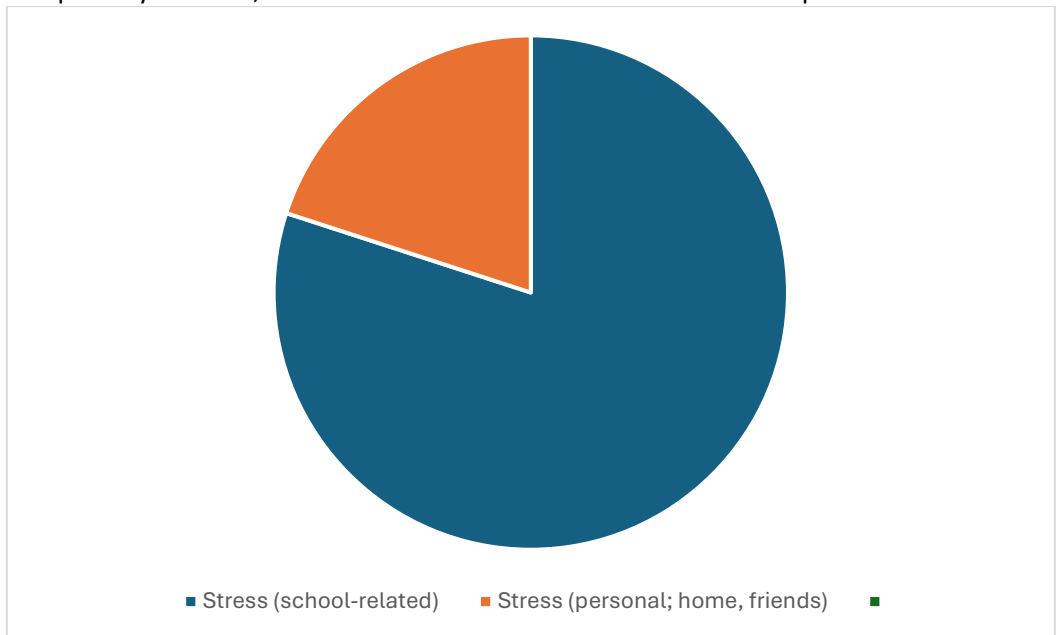

Enrollment and Status Update

- We are currently serving 119 freshmen and sophomores from low-income and first-generation (LIFG) backgrounds, as well as students with disabilities.
- Recruitment is going well. We are required to serve a minimum of 165 qualifying students prior to August 31, 2026.
- Two-thirds of our enrollment need to be students who we consider to be double-qualifiers, i.e. students who are either (1) LIFG or (2) low-income and disabled (LID). One-third of the students with disabilities we serve must also be students from low-income families.

Enrollment Update

- We are in the fourth year of our current grant cycle. The reporting period for the current year will close on May 31, 2026. At present, we are officially serving 55 participants from grades 9-12 at Andrew Jackson, Buford, and Lancaster High Schools. We are required to serve a minimum of 62 qualifying participants each year. To qualify, participants must have completed the 8th grade, be between the ages of 13 and 19, and have a need for academic support to pursue a program of postsecondary

education. All participants must be either from low-income families or be potential first-generation college students – or be determined to have a high risk for academic failure.

- We are currently reviewing summer pre-admits alongside 45 outstanding applications. This position allows us to not only meet, but most likely exceed, our required minimum enrollment of 62 participants. The maximum number we are authorized to report is 74.

Academic and Recruitment Sessions

- **Mark Ammons** and **Matt Williamson** held a recruitment session at Buford High School on January 22. We connected with 32 potential participants and are excited to review their applications.
- We are currently working with the counseling staff at our three target schools to arrange in-person academic session visits with our current participants for the Spring 2026 semester. We are planning two sessions per month at each school. In addition, plans are being made to have several Zoom meetings with parents who are unable to attend on-campus sessions. There is no doubt that this new approach to recruit and provide services to participants in this manner will be a “game changer” as we seek to increase the numbers of participants from rural Lancaster County schools.

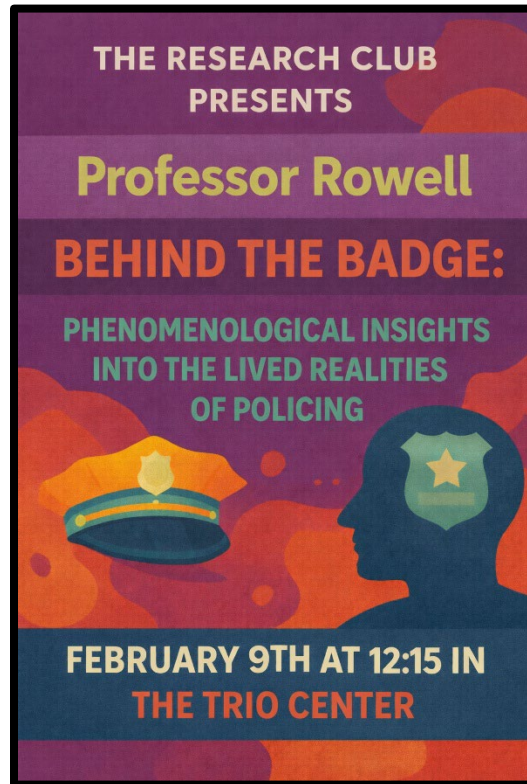
D.E.F.I.N.E. and G.E.N.T.S.

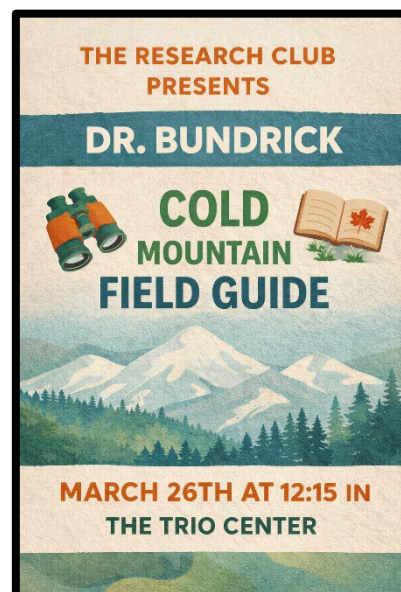
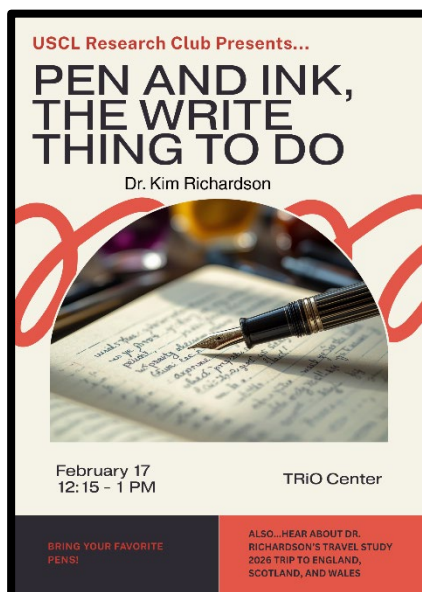

System Affairs Report

- Faculty Workplace Incivility and Faculty Progressive Discipline

- Proposed changes to BLS and BOL

- I. **Faculty Workplace Incivility and Faculty Progressive Discipline proposals.** We recommended that these proposals be sent to the Policy Committee and then to the full faculty, in accordance with previously agreed-upon procedure.
- II. **Grievance procedure proposal.** The faculty submitted changes to our grievance procedures last year and got provost's office feedback in August recommending three minor changes. System Affairs agreed to fix a typo, to specify that grievance-related communications be sent through our university email addresses, and to tighten up vague phrasing in a section about failure to meet deadlines to mirror Columbia's more specific language. A plan for grievance committee training will be proposed this spring.
- III. **Recommended changes to BOL and BLS degrees.** We voted unanimously to approve a dance major option for the BLS, as suggested by Steve Lowe. While dance majors are by no means particularly high-earning college graduates, the current Bureau of Labor Statistics Occupational Outlook Handbook indicates that the number of jobs in dance-related fields (choreography, teaching, arts administration, dance itself) is likely to increase more than most in the foreseeable years. The major option for the BLS will require an additional major option to accompany dance, along with a cognate. USC anticipates relationships with the Joffrey Ballet as well as with the Palmetto Conservatory of Dance.

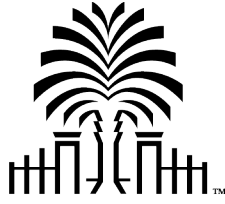

Greetings system affairs members.

At our last academic advisory meeting, we discussed the following to forward to system affairs for consideration and a vote of the senate. On our agenda was consideration of a number of courses that we would like to add to the curricula of the Liberal Studies or Organizational Leadership degree programs. Many of these courses have been used as substitutes for courses already in those programs, but new financial aid regulations require all courses to be part of a student's curriculum.

Course or requirement	Substitute Course	Explanation/Justification
GFL 122-level	Approved substitution	Students with courses other than SPAN 109/110 have no access to 122-level courses. Also, many students who have SPAN 109/110 (or the equivalent) have not taken a language class in years.

ITEC 264 (BOL)	MGSC 290	Very similar courses; many students have taken MGSC 290

PRESIDING CHAIR LIAM HEIN

The minutes from the December 3 meeting were approved.

Report from the Provost

Provost Fitzpatrick gave an update on the status of PTF guidelines across the university. In October 2023, a memo was issued requiring units to begin developing a second promotional step beyond Senior Instructor due to concerns about limited advancement opportunities. This action was taken in anticipation that Faculty Manual revisions might not pass in a timely manner. The Faculty Manual revisions were approved in 2024, followed by State HR approval of new faculty titles in October 2024. The College of Education became the first unit with approved PTF criteria (October 2024), using college-wide guidelines with department-level committees.

The Provost outlined the responsibilities of the Office of Faculty Affairs, including Review of tenure-track and PTF criteria, Tenure and Promotion file reviews, governance and committee support (including UCPTF and Board of Trustees), and faculty manual oversight, civility investigations, grievance processes, and policy development.

For faculty going up for promotion under the existing guidelines, they cannot transfer into a new title series until new guidelines are approved. The Provost thanked faculty, Senate members, and Office of Faculty Affairs staff for sustained efforts over a multi-year process.

Guest Speaker: Dr. Cathy Ford, Co-Founder, Stand Together for Higher Ed

****Dr. Ford's PowerPoint presentation is available on the Faculty Senate website with the materials from the January 14th, meeting.****

Here is the overview of information: Stand Together for Higher Ed is a faculty-led, nonprofit, nonpartisan organization focused on protecting academic freedom, strengthening shared governance, and protect the public mission of higher education. Stand Together is not a union or an institutional advocacy shop. They help build collective capacity so faculty and staff can make their own informed decisions in their own contexts about how to protect academic freedom and shared governance. Dr. Ford emphasized narrative change—helping faculty and staff across the country tell authentic public stories about how valuable higher ed is to the public good in local and state contexts—as a complement, not a replacement, to governance and advocacy. The point is to provide a different story in contrast to the distortions of higher ed that have taken root in public discourse. Dr Ford focused on one initiative through Stand Together, Reclaim the Narrative. The initiative trains faculty and staff to share local, human-centered stories through op-eds, letters to the editor, social media, and media interviews. Reclaim the Narrative focuses on faculty and staff voices, not institutional messaging, and has a flexible, voluntary, and locally adaptable framework. There is a 3-hour workshop available, if interested in learning more.

The minutes from the January 14, 2026 meeting were approved.

No report from the President

Report from the Provost

The Provost's report focused solely on AI in the USC system. She stressed that students will use AI regardless, so promoting ethical fluency is key. USC has purchased licenses for ChatGPT, Microsoft Copilot, and others, with the justification that these licenses ensure safe use without risking confidential data. She highlighted existing AI tools like the USC Campus Resource Guide, Cocky Scholar, and Garnet Guide, plus support and training programs such as the Garnet AI Foundry, the IT Group's café drop-in hours, The Center for Teaching Excellence, the Carolina Grant and Innovation Hub, the Provost AI Fellows program, and Thomas Cooper Library.

Following two AI retreats, she noted USC leads nationally in AI efforts. She reiterated the importance of AI fluency and indicated that she is piloting a program where AI student interns assist faculty in research and teaching. Currently in the USC Columbia Honors College, this pilot will train students on AI tools and pay them to work with faculty on research and teaching projects. She mentioned a pilot AI fluency assessment with 450 participants, now integrated into University 101, emphasizing ethics and professor-specific AI use expectations. Students who complete U101 will receive a digital badge.

The Office of Student Conduct is developing AI-related academic integrity guidelines. The Provost cautioned that current AI detection tools are ineffective, hence her reluctance to purchase them. The ASPIRE grant now has an AI program to provide faculty with the opportunity to pursue AI research, and the University is developing an Advising and Registration Companion chatbot called "ARC," that will assist students with common questions—aiming to free advisors from transactional tasks. Additionally, Enrollment Management is seeking AI-based transcript review tools. She acknowledged the schools and colleges moving ahead with embedding AI into their processes, including HRSM, the Business School, CIC, the School of Education, and the Law School.

The floor was opened for questions, which covered how the University is managing the ethical, political, and environmental issues inherent in AI use, the size of the incoming Freshman class and current housing projects, and the University's protocol for responding to the death of a student.

Reports from Faculty Standing Committees

- *Committee on Curriculum and Courses* provided the month's proposals (linked in the agenda) without any special comments. A motion was raised to approve the proposals. The motion passed.
- *Faculty Advisory Committee* withdrew the proposed changes to the faculty manual due to last-minute revisions. It will be brought before the Faculty Senate for notification at next month's meeting.

Report from the Chair

The Chair noted the deadline to be in compliance with the [Department of Justice Rule on Digital Accessibility](#) is April 2026. He directed senators to the educational resources provided by the [Center for Teaching Excellence](#).

Regarding CPHE, the Faculty for Responsible Education and Accreditation met on January 26th to share suggestions for Evidentiary Guidance. CPHE has opened the [draft evidentiary guidelines](#) for [public comment](#).

The Chair reiterated the need to have new faculty senators elected by the spring semester, so they can attend orientation. He also solicited calls for chair-elect nominations. There were 89 volunteers for Faculty Senate committees.
