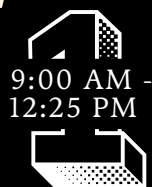

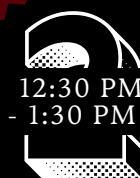

- **Financing Child Care and Returns: What Works for Families, Providers, and the Workforce** - *Dr. Luke Rodgers* (Florida State University) takes an evidence-based look at how child care is financed, who gains access, and how policy choices affect families, providers, and labor-force participation.
- **Classrooms in the Digital Age: Cell Phones, AI, and the Evidence on Learning** - *Dr. Breyon Williams* (Groundwork Collaborative) discusses what research tells us about classroom technology - from student cell phones to artificial intelligence - and how schools can make better adoption decisions.
- **Every Day Counts: Understanding and Reducing Chronic Absenteeism** - *Dr. Sarah Komisarow* (Duke University) examines what causes students to miss school, how economists measure the consequences, and which policies show promise for improving attendance.
- **Paying for College - and Making College Pay Off: Evidence on Postsecondary Access and Success** - *Dr. Jeffrey Denning* (University of Texas at Austin) explores how college costs, financial aid, and education pathways shape enrollment, completion, earnings, and financial well-being - and how linked education data help researchers identify when and for whom college pays off.

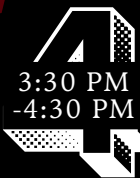

- **Immigration Policy at Work: Effects on Workers, Families, and Local Economies** - *Dr. Catalina Amuedo-Dorantes* (University of California, Merced) delves into how immigration policies affect employment, earnings, families, and communities - and how economists separate policy effects from broader labor-market change.
- **Rules, Skills, and Opportunity: Regulation in Education and Labor Markets** - *Dr. Alicia Plemmons* (West Virginia University) explores how licensing and other regulations shape education-to-career pathways, entry into occupations, worker mobility, and the ability of employers and communities to meet unmet workforce needs.
